In the spring of 2021, BUESD held a community meeting and sent surveys to solicit community and staff engagement.

In the fall of 2021, BUESD send out a ESSER III specific survey to allow the community an opportunity to provide input regarding spending for learning loss and encouraging in-person learning.

Families, staff, and community members are invited to attend school board meetings to share in the discussion of ESSER III. The Board Meeting with specific ESSER III agendized includes fall of 2021. However, staff, families, community members, and board members are welcome to speak regarding ESSER III at any regularly scheduled board meeting.

Families have made it clear that they need assistance with transportation to school on a regular basis.

A description of how the development of the plan was influenced by community input.

Community and staff members noted that students on campus should have the benefit of clean air. The new HVAC with updated filters will provide improved air quality.

In addition, community and staff members agreed that learning loss should be addressed through daily intervention and summer school for identified students. One .45 FTE will be provided through ESSER III funds in the 2022-2023 school year for targeted ELA and Math interventions. Summer School for summer 2022, summer 2023, and summer 2024 will be funded to provide opportunities for academic support with targeted interventions.

Families need assistance with transportation to school, so BUESD will need to purchase one school van for the use of daily transportation to school.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
